This year, Lincolnshire Police Authority (LPA) had originally increased its part of your council tax bill for 2008-09 by 78.86% (which is £2 per week for a band D household). However, the Government instructed the LPA to reduce its council tax. The reduction it then made was £69.57 for band D properties. Compared to last year, the new level of council tax for the LPA for 2008-09 is now a 25.99% increase from last year (or 66p per week for a band D household). South Holland District Council is sending replacement bills to everyone during August 2008.

It is not appropriate for SHDC to try to answer enquiries or correspondence about the Police Authority's council tax increase. Instead, you can read what they have said about it in the booklet that comes with your bill. Your council tax bill is made up of four different amounts. The main share goes to Lincolnshire County Council. The second largest share is for Lincolnshire Police Authority. These are followed by shares for SHDC and the parish or town in which you live. Each of these organisations set their own council tax. After consultation, SHDC's increase has been set at 2.75% which is our lowest increase since 2001-02. It means that our services will cost the average household in South Holland only £2.23 a week.
