

# **The South Holland District Council (Reorganisation of Community Governance) (Cowbit) Order 2023**

Made 21 March 2023

*Coming into force in accordance with article 1(2)*

South Holland District Council ("the council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 18 January 2023.

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section.

The council makes the following Order in exercise of the powers conferred by sections 86, 98(3), and 240(10) of the 2007 Act.

## **1 Citation and commencement**

- 1.1 This Order may be cited as the South Holland District Council (Reorganisation of Community Governance) Cowbit Order 2023.
- 1.2 It shall come into force on the ordinary day of election of councillors in 2023.

## **Interpretation**

2. In this Order -

"county" means the county of Lincolnshire;

"district" means the district of South Holland;

"existing" means existing on the date this Order is made;

"map" means the map marked "Map referred to in the South Holland (Reorganisation of Community Governance) Order 2023" and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

"ordinary day of election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983.

**Effect of Order**

- 3. This Order has effect subject to any agreement under section 99 (arrangements about incidental matters) of the Local Government Public Involvement in Health Act 2007 relevant to any provision of this Order.

**Parish elections**

- 4. The election of all parish councillors for the parish of Cowbit shall be held simultaneously on the ordinary day of election of councillors in 2023.

**Number of parish councillors for the parish of Cowbit**

- 5. The number of councillors to be elected for the parish of Cowbit shall be 7.
- 5.1 The term of office of every parish councillor elected on the ordinary day of election of councillors in 2023 for the parish of Cowbit shall be four years.

**Order date**

- 6. 1 April 2023 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

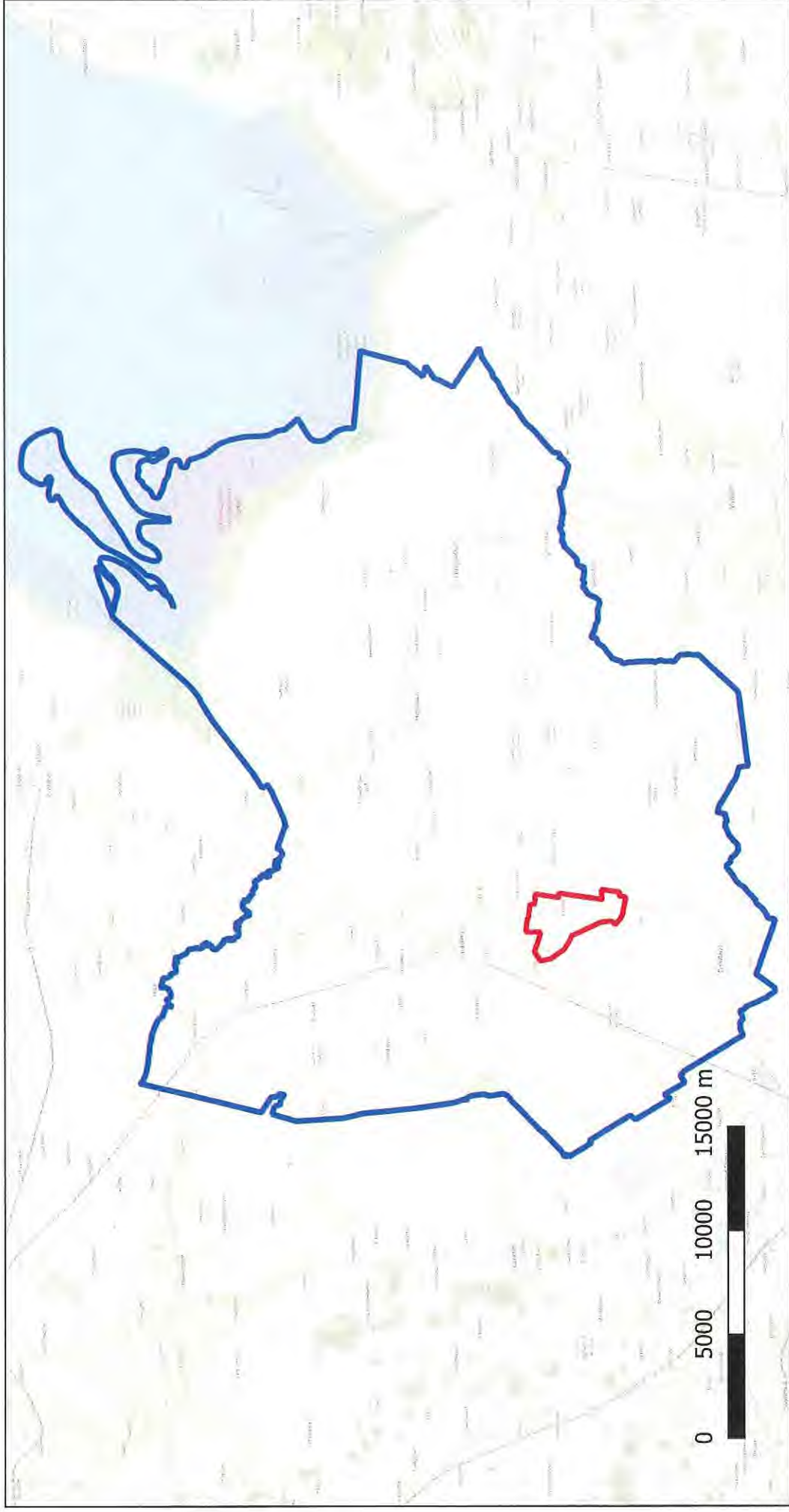

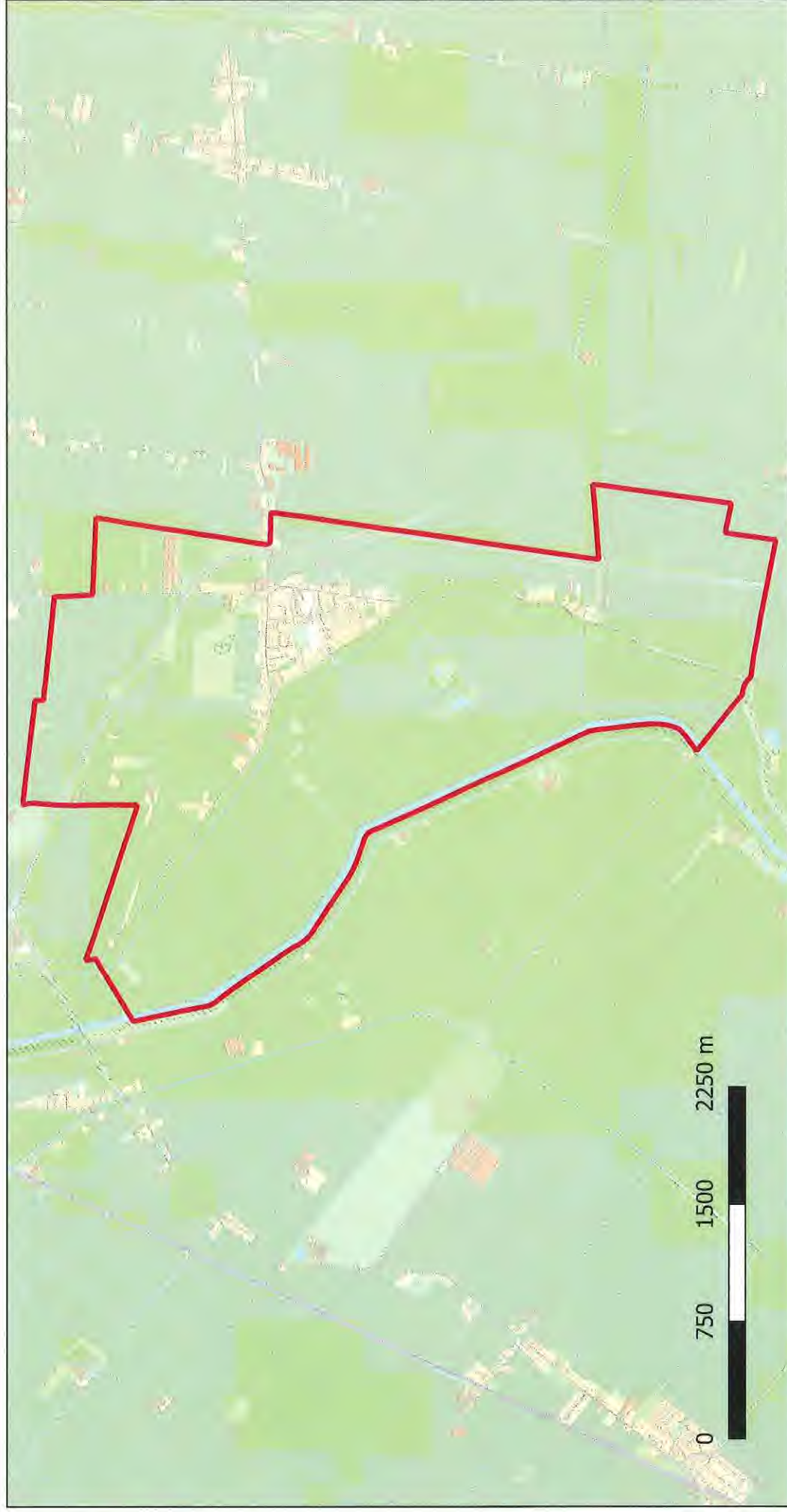
# Cowbit Parish Map
