Premises which are not liable to or are exempt from non-domestic rating will fall into the Band A category.

Exemptions from paying a fee

No fee or annual charge will be payable by church halls, chapel halls or other premises of a similar nature and village halls, parish and community halls or other premises of a similar nature for a Premises Licence or a Club premises Certificate authorising only the provision of regulated entertainment.

However, a licence authorising the sale of alcohol or late night refreshment would require a fee.

A school or college premises that forms part of the school or college is exempt from the licence provided the provision of regulated entertainment on the premises is for and on behalf of the school or college. Again, a licence authorising the sale of alcohol or late night refreshment would require a fee.

Exceptionally large events of a temporary nature requiring premises licences

Where exceptionally large events of a temporary nature take place, such as major festivals and other events, and the proposed number of people at any one time attending such a temporary event would exceed 5 000 people, an additional fee will be charged on an application for a premises licence authorising the event.
